RIIWHS302E TRAFFIC MANAGEMENT IMPLEMENTATION TRAINING PROGRAM

RENEWAL PROGRAM

Course Overview

To continue to be recognised as a TMI Officer in Queensland you must demonstrate ongoing familiarity with MUTCD Part 3 and AUSTROADS guidelines, and any relevant changes to road rules, by completing a renewal training course before the date of expiry. The course consists of the following units of competency:

- RIIWHS302E Implement traffic management plans
- RIIRIS301E Apply risk management processes

Course Duration

Formal Training -1 full day of face-to-face training (up to 9 supervised hours; may be extended if additional training required)

Day 1 - Training and Assessment

In determining if a person is eligible to undertake the full day renewal training course, AATS must assess the following evidence:

- demonstrated knowledge of Traffic Management Implementation procedures
- demonstrated three years on-the-job industry experience.

To achieve a successful outcome in the renewal course, participants must demonstrate successful completion of in-class trainer observations, written and practical assessments.

Assessment

Students must provide a completed TMI Currency of Industry Practice (COIP) at enrolment prior to undertaking the renewal program. This documentation includes two (2) Third Party Reports from a workplace supervisor. Other assessment is conducted in class which includes completion of a case study as a group exercise.

Topics Covered

- Plan and prepare for risk management
- Assess and identify unacceptable risk
- Review risk management documentation
- Identify and recommend controls
- Contribute to the implementation of controls
- Plan and prepare to implement traffic management plan
- Set out the traffic guidance scheme
- Monitor traffic guidance scheme
- Close down traffic guidance scheme
- Clean up

Entry Requirements

AATS policy requires students to be a minimum of 18 years of age prior to enrolling and attending this course due to WHS considerations and licensing requirements. Students must be working in industry and be current to enrol in the renewal course.

Resources Required

Students are required to wear appropriate clothing including high visibility long sleeve shirts, long pants, work boots, and sun protection during training. All written material and stationery are supplied for the course. Students must provide their own food; fridges are available onsite. Tea and coffee are supplied by CCT.

Pre-Requisites

Students undertaking the renewal course must already hold RIIWHS302E and a current QLD Traffic Management Implementation Program card. Additionally, students must show evidence of completing the TMR eLearn programs Working in Proximity to Traffic Parts 1 & 2 and submit a completed Currency of Industry Practice (COIP) form with supporting evidence (third party reports x 3; TGS; toolbox; SWMS; risk management plan) prior to enrolment. Enrolments cannot be accepted without this evidence.

Outcome / Accreditation

Upon successful completion of the course components, students will be issued with statement of attainments for the units of competency RIIWHS302E and RIIRIS301E and a wallet-sized card. This certification expires again three years after the date of completion. To continue working on Queensland roads, a renewal course is required before the date of expiry.

Pathways

Both units of competency can be credited towards skillsets and/or qualifications in the Resources and Infrastructure Industry Training Package.
