RIIERR203E | ESCAPE FROM HAZARDOUS SITUATIONS UNAIDED

Unit Overview

This unit describes the skills and knowledge required to self-evacuate from hazardous situations in an underground mining environment. It applies to individuals working in an underground mine who may be required to escape unaided in emergency conditions, such as fire, inrush, or gas exposure. Training includes hazard identification, emergency response protocols, and the correct use of self-contained self-rescuers (SCSR) in simulated conditions. Participants will develop the confidence and capability to navigate escape routes under stress, ensuring compliance with site safety regulations and emergency management procedures. This unit is typically delivered as a one-day program incorporating both theoretical and practical assessment components in a controlled environment.

Duration – 1 Day

8 hours of supervised activities (mixed mode delivery)

Unit of Competency

This upgrade program focuses on the nationally recognised unit RIIERR203E – Escape from hazardous situations unaided and is designed for workers who have already completed the S11 surface induction requirements. This course provides the critical underground emergency preparedness training needed for underground operations. You'll learn to respond safely in the event of fire, explosion, or other lifethreatening hazards – a mandatory capability for underground mining.

- Plan and prepare for escaping from hazardous situations unaided
- Assess and withdraw from hazardous situation
- Evacuate to fresh air
- Participate in post-incident debrief

Cost

\$350 - full course

\$250 - refresher course

Assessment - Same day

Learners cannot attempt their theory and practical assessment for the course until training has successfully been completed. Should re-assessment be required the fee is \$450.00 payable before the attempt at assessment is conducted.

Course Validity and Refreshers

The refresher period for the mining unit(s) is five years, a shorter period may be required where industry/company requirements are applicable. Individuals can refresh their competencies anytime within the five-year period in line with these industry/company-specific requirements.

Entry Requirements

CCT policy requires students to be a minimum of 18 years of age and have at least a Year 10 level of numeracy, literacy and communication skills prior to enrolling and attending this course. *Must already have completed the S11 course and hold units from the skillset RIISS00034 Surface Coal Mine Safety Skill Set.*

Resources Required

Students are required to wear appropriate clothing including high visibility long sleeve shirt, long pants, work boots, and hard hat during training. Machinery and equipment are supplied when training at our facility. All written material and stationery are supplied for the course. Students must provide their own food; fridges are available onsite. Tea and coffee are supplied by CCT.
