

RIISS00034 | SURFACE COAL MINE SAFETY SKILLSET (Standard 11)

Course Overview

The skillset and course is designed to provide individuals with the essential safety knowledge and skills required to work safely in surface coal mining operations. It is a mandatory requirement for workers entering the Queensland coal mining industry and covers risk management, hazard identification, emergency response, and site safety procedures.

Course Duration – 2 Days

1 Day online training

1 Day in person assessment

Units of Competency

- RIIWHS201E - Work safely and follow WHS policies and procedures
- RIIERR205D - Apply initial first aid
- RIIGOV201E - Comply with site work processes/procedures
- RIIRIS201E - Conduct local risk control
- RIICOM201E - Communicate in the workplace
- RIIERR302E - Respond to local emergencies and incidents

Cost

\$600 – full course

\$400 – refresher course

Assessment - 1 day

Learners cannot attempt their theory and practical assessment for the course until training has successfully been completed. Should re-assessment be required the fee is \$450.00 payable before the attempt at assessment is conducted.

Course Validity and Refreshers

The refresher period for the mining unit(s) is five years, a shorter period may be required where industry/company requirements are applicable. Individuals can refresh their competencies anytime within the five-year period in line with these industry/company-specific requirements.

This course is a requirement of the Coal Mining Safety and Health Act 1999 Division 2 Section 56 and of the Mining and Quarrying Safety and Health Act 1999 Division 2 section 51.

Pre-Requisites

Nil.

Pathways

Successful completion of this skill set provides a pathway to further qualifications within the RII Training Package, such as the Certificate II or III in Surface Extraction Operations or Certificate IV in Underground Coal Operations. It can also contribute to competency for specialised safety and emergency response roles in the mining industry.

Outcome

Upon successful completion of the course the student will be issued a Statement of Attainment under the Australian Qualifications Framework, this certification is nationally recognised.

RPL/RCC

In some cases, students may possess skills and or knowledge in the course content. CCT will assess your eligibility for RPL/RCC. Information on RPL/RCC can be found in the CCT student handbook, on our website or by contacting our office.

Entry Requirements

CCT policy requires students to be a minimum of 18 years of age and have at least a Year 10 level of numeracy, literacy and communication skills prior to enrolling and attending this course.

Resources Required

Students are required to wear appropriate clothing including high visibility long sleeve shirt, long pants, work boots, and hard hat during training. Machinery and equipment are supplied when training at our facility. All written material and stationery are supplied for the course. Students must provide their own food; fridges are available onsite. Tea and coffee are supplied by CCT.
